Waiver of Liability and Hold-Harmless Agreement**

For good and valid consideration, the sufficiency and receipt of which are hereby fully acknowledged, I hereby forever release and discharge any and all claims of any kind or nature whatsoever that might arise from or be associated with my participation in or attendance at a Valley Creates event in 2016. Without limiting the breadth of the foregoing:
